  - d. CARES Act Sanitation and Cleaning Anticipated Expenditures Board made a motion to apply for reimbursement of said expenses for new water coolers and sanitation stations up to \$7,005.40. Motion seconded and approved.
  - e. Florida Safe Schools Assessment Plan presented. Perimeter fencing, enhanced camera system, and a rave panic button on each phone that will send campus wide alert. Motion made, seconded and approved plan as presented.
  - f. Esser Fund Grant presented Board made a motion to apply for reimbursement of said expenses for Chrome books, sanitizer, desk guards, and outdoor cafeteria up to \$115,795.97. Motion seconded and approved.
  - g. Reopening Plan for 2020-2021 presented. Some classrooms are using google classroom, students have chrome books to check out, synchronius learning, camera in each classroom, some have live streaming. Board made motion to accept plan, seconded and approved.
